THE ORDER OF THE COURT IS THAT:

- 1. The orders made by Callaghan J on 23 March 2021, be varied as follows:
 - (a) by adding to paragraph 4(a), immediately after the word "recorded", the words "as that member's preferred method of communication";
 - (b) by amending paragraph 4(b) so that it reads: "The First Respondent shall send the Notice by post to those members of the FMIF for whom a postal address is recorded as that member's preferred method of communication in the Register";
 - (c) by adding to paragraph 12(b), immediately after the word "recorded", the words "as that member's preferred method of communication"; and
 - (d) by amending paragraph 12(c) so that it reads: "The First Respondent shall send the Schedule 1 Notice by post to those members of the FMIF for whom a postal address is recorded as that member's preferred method of communication in the Register".
